3. You should also note that when this document is exported to Microsoft Excel format it may abbreviate descriptions. Therefore, you should read all descriptions from the PDF of Volume C – Pricing Document provided with the tender package.
4. Tenderers should also note that the MS Excel file HAS NOT been fully formatted and it is the contractors responsibility to ensure that all items are included in the overall total sum.
5. Tenderers should also note that this file is issued for work purposes only and **must not** be returned as a tender. Each tenderer is required to return a printed copy of the published PDF version Volume C as part of their tender submission, fully priced and totalled to arrive at the tender amount entered on their Form of Tender.
6. Only the PDF version of Volume C – Pricing Document carries the status as a tender document. In the event of a conflict between the content, including descriptions and quantities, between the PDF version and that of the Excel files, the PDF version will be deemed to be correct.

Note for Use of CBX (CUBIT / BUILDSOFT) Version of the Pricing Document

2. Tenderers should note that the information contained in the Cubit file will **NOT** be in the same format as the PDF version of Volume C – Pricing Document provided with the tender pack (i.e. Page Numbers, References, Collection Pages, General Summary, etc.).
3. Tenderers should also note that this file is issued for work purposes only and must not be returned as a tender. Each tenderer is required to return a printed copy of the published PDF version Volume C as part of their tender submission, fully priced and totalled to arrive at the tender amount entered on their Form of Tender
4. Only the PDF version of Volume C – Pricing Document carries the status as a tender document. In the event of a conflict between the content, including descriptions and quantities, between the PDF version and that of the Excel files, the PDF version will be deemed to be correct.
5. Tenders should note that the Volume C pricing document was prepared on Cubit (CBX format). Tenderers should be able to convert this pricing document into Buildsoft (EOX format) themselves. Contractors should be aware that when this document is exported to Buildsoft full descriptions may not transfer due to their length or the use of special characters. As per note 4 above Only the PDF version of Volume C – Pricing Document carries the status as a tender document. The tenderer must refer to the pdf document to read all descriptions
