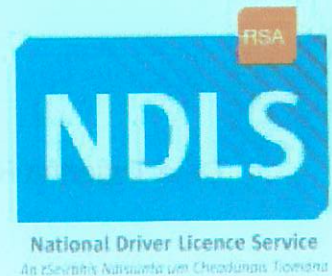

Re- Expiry of Driving Licence

Our records show that your driving licence or some categories thereon is about to expire.

You can now quickly and easily renew your driving licence online at www.ndls.ie. You must have a Public Services Card (PSC) and a verified MyGovID account. For more information about a PSC visit www.mywelfare.ie. If you have a PSC but do not yet have a verified MyGovID account, it is simple to set up, you just need to visit www.mygovid.ie.

Alternatively, you can attend an NDLS centre, but you must book an appointment in advance on www.ndls.ie

- Medical and Eyesight Reports (if required) available to download at www.ndls.ie

A medical report is required if you;

- Are aged 75 years and over or your previous licence expires on the eve of your 75th birthday.
- Have bus or truck categories on your driving licence and wish to renew them.
- Answer "yes" to a specified medical condition listed in your application.

You can renew your driving licence up to three months before it expires, your new driving licence will commence from the date of application, any time left on your old one will not be applied to your new driving licence.

In some cases, because of incomplete information available to the National Vehicle Driver File, this letter may be addressed to a deceased person. We apologise for any distress this may cause. A family member of the deceased may email the bereavement to NDLS at info@ndls.ie or in writing to National Driver Licence Service, PO Box 858, Southside Delivery Office, Cork, and no further correspondence will issue.
