You are hereby notified, pursuant to section 5 of the Road Traffic Act 2002 that, following payment of a fixed charge in respect of an alleged offence of Use vehicle without NCT certificate which occurred on the 2 May 2023, 3 penalty points have been endorsed on the entry in the licence record relating to you.

The endorsement of these Penalty Points means you have reached or exceeded the maximum number of Penalty Points allowed. As a result you will be disqualified from driving for a period of six months, commencing on 1 January 2024, subject to your driving licence being current and valid throughout that period.
