

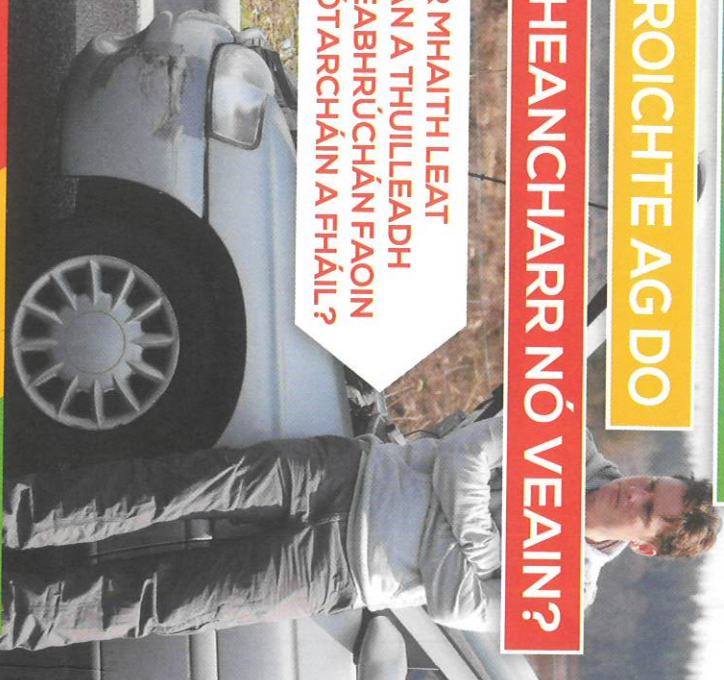

Baineann an t-eolas seo le:

- Carranna baile nó paisinéara/SUVanna/veineanna (gan breis agus 9 sulochán).
- Veineanna tráchtála/feithicil éadroma earraí (faoi mhéadhan 3,500kg).

Is éard is Saoráid Chóirela Údairithe (SCÚ) ann ná cíos conamair ceadaithe a ghlacann le d'fheithicil saor ó tháille (má tá sé iomlán agus gan brúscar ann).

Féadtar SCÚ atá gar duit a aimsiú ach seiceáil ar shuíomh Idirlin d'Údaráis áitiúil. Má tá do char ó scrápáil agat, ba chóir SCÚ a úsáid i gcónaí. Mura n-úsáideann, seans go ngearrfar fineáil €100 ort.

Ní fhéadann ach SCÚhna Deimhniú Scríosta (CoD) a eisíúint duit.

Is éard a dhéantar leis an Deimhniú Scríosta ná go maircédánn sé d'fheithicil mar fheithicil scrápáilte ar bhunachar láir na Roinne Iompair.

Nuair a bheidh Deimhniú Scríosta eisithe, ní bhfaighidh tú meabhrúcháin mhótarachánach a thuilleadh.

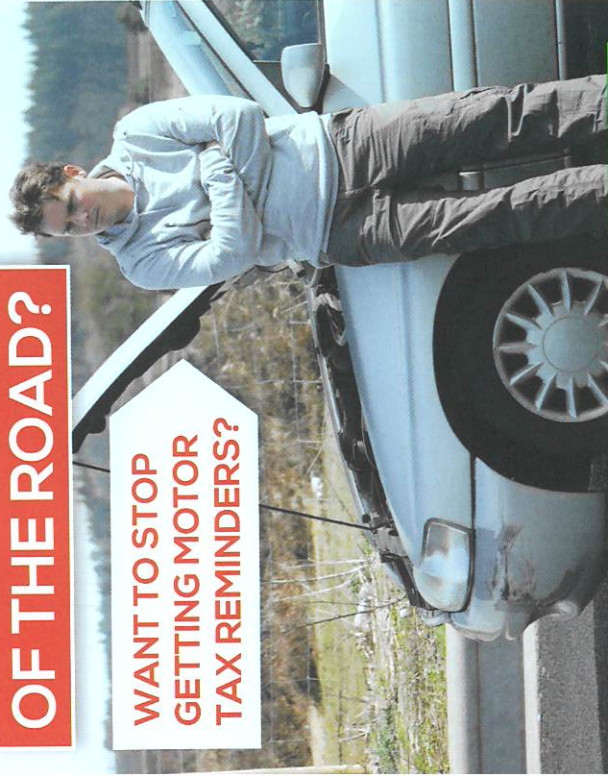

Scrapping a Car or Light Commercial Vehicle: What you need to know

This information applies to:

- Domestic or passenger cars/SUVs/vans (no more than 9 seats).
- Commercial vans/ light goods vehicles (under 3,500kg in weight).

An Authorised Treatment Facility (ATF) is a permitted scrapyard that will accept your vehicle free of charge (if it is complete and free of rubbish).

You can find an ATF near you by checking your local authority website. If you are scrapping your vehicle, you should always use an ATF. If you do not, you could be liable for a €100 fine.

Only ATFs can issue you with a Certificate of Destruction (CoD).

A CoD marks your vehicle as scrapped on the Department of Transport's central database.

Once a CoD has been issued, you will no longer receive motor tax reminders.
