1.	Turnover May we request a reduction in the Minimum Turnover level for Architect to €350,000. We note QC2 Part states Architect Design Services – Average Minimum Turnover: €700,000. We note the Steam Mill project has a estimated budget of '€6m to €9m to €12m'. We also note the project is 'expected to be put forward for Category 1 RRDF funding'. The current RRDF funding call has a €10m funding limit unless exceptional circumstances so it is likely the Steam Mill project will be targeted within the €10m envelope. Capital Works Management Framework Guidance Note 1.6.3 on page 16 notes for project Value of €10million the suggested Average Minimum Turnover is €350,000. We would respectfully suggest this is a more appropriate level of turnover for this tender. A turnover of €500,000 would only be applicable to a project with a value of between €15m and €20m according to the above noted guidance note.
