(1) if you were not driving or otherwise using the vehicle referred to in this notice at the time of the commission of the alleged offence you must as required by section 3 (3) of the Local Authorities (Traffic Wardens) Act 1975 - (a) not later than 28 days after the date of the notice, give or send the document below signed by you stating the name and address of the person who was driving or otherwise using the vehicle at the time of the commission of the alleged offence to Cork County Council, Parking Fines Unit, Floor 5, County Hall, Cork. and (b) give or send to the above authority at the above address within such a period as may be specified by it such other information within your knowledge or procurement as Cork County Council may reasonably request for the purpose of identifying and establishing the whereabouts of the person who was then driving or otherwise using the vehicle.

(2) if a payment referred to in paragraph 1 of this notice accompanied by this notice, is made during the period referred to in that paragraph you need not comply with the requirement in sub paragraph (1) above.

(3) if you comply with sub-paragraph (1) above you do not need to make the payment referred to in paragraph 1 of this notice, and a prosecution in respect of the alleged offence will not be initiated against you.

(4) Other than in the circumstance referred to in sub-paragraph (2.3) above, failure to comply with sub-paragraph (1) being a failure to comply with section 3 (3) of the Local Authorities (Traffic Wardens) Act 1975 is an offence upon summary conviction which you are liable to a fine not exceeding €1,000.

Data Protection

Cork Council (the "Council") will use the personal data it collects (including the vehicle registration) to send a Notice to Owner, any related correspondence, and any further notices if this Fixed Charge Notice remains unpaid. You have 28 days to pay this Fixed Charge Notice from the date on which it was served. After that further action may be taken and the personal information may be used to obtain the name and address of the registered owner address which may then be used to enforce this Fixed Charge Notice. The Local Authorities (Traffic Wardens) Act, 1975 requires us to do this. The Council does not need your permission to process this information for this purpose. The personal information will be used by the Council's parking and traffic enforcement teams. The personal information will be retained for 6 years following the completion of processing.
