A two-storey extension was added to the rear in the 20th Century. The Irish Heritage Trust has entered into a partnership with Poetry Ireland and the Irish Landmark Trust to bring No.11 Parnell Square to life as a poetry centre, cultural hub and headquarters for the three organisations. The intent of the proposed works is to revitalize this important Georgian house and to return it to full use as a significant part of the Parnell Square Cultural Quarter.
