As these are Title III type services as per the Regulations, Enterprise Ireland is employing a single stage procedure with negotiation and any interested party may submit a tender. Those tenders will be evaluated to ensure they meet the specification, selection and award criteria. Following the initial tender evaluation, Enterprise Ireland reserves the right to: (a) move straight to a contract award decision, without negotiation (b) apply the successive reduction rule to invite the top two scoring tenderers from the evaluation of tenders to the negotiation phase subject to that number qualifying, however, Enterprise Ireland reserves the right to invite the third top scoring tenderer, to ensure there are at least two Tenderers remain in the negotiation phase, in situations such as but not limited to: i. new information coming to light affecting the scores/ admissibility of either of the top two invited tenderers such that the third scoring tenderer moves up the ranking ii. one of the top two tenderers withdraws from the negotiation phase (c) invite Tenderers ranked after the third top scoring Tenderer in line with the above moving through the ranked order if necessary (d) invite the third scoring tenderer where the second and third scoring tenderers are tied (e) invite all tenderers to negotiation meetings. 8 The Negotiation Stage Where negotiation meetings take place, all aspects of the tender submitted may be discussed, including costs. Those tenderers will subsequently be afforded an opportunity to submit a Best and Final Offer (BAFO), which will be assessed against the award criteria. It should be noted that Enterprise Ireland reserves the right to establish Frameworks and award call off contracts (where relevant) without recourse to negotiations with individual tenderers.
