Description: As visitor numbers continue to rise, vehicular pressures highlight the need for more sustainable and coordinated approaches to managing access to the region. In response to these challenges, the National Parks and Wildlife Service (NPWS) Burren National Park and Clare County Council partnered to introduce a free, hop-on hop-off shuttle bus service for the 2025 summer season. The service connected key towns, villages, and visitor attractions across North and West Clare, supported by dedicated free parking areas to encourage visitors to leave cars behind. This initiative represented a significant step toward improving traffic flow, reducing environmental impact, enhancing visitor safety, and supporting a more sustainable tourism experience.
