*Other justification:* Competition is absent for technical reasons. • There is a significant risk to the ongoing operation of CCTS, CSOL, Apex and Oracle if the support services are moved to a new supplier. • Moving to a new supplier at a critical juncture would cause significant delays to the Modernisation Projects due to the need to involve transfer of business and ICT knowledge. • The one off and short-term nature of the contract is unlikely to be attractive to alternative suppliers.
