South Kerry Greenway – Section 2 (CH 18200 to CH 25650) Construction a 3m wide paved surface cycleway. Reconstruction of bridge deck at CH 18750. Drainage outfalls. Gabion structures at Ch 19720 TO Ch 19910, 190m of Gabion Structure West of Drung Hill, Drunghill Tunnel West, 750m Gabion Structure East of Drung Hill Gabion Structure. Road realignment works to N70 at Caitins Beaters. Structural works at Gleesk Viaduct. New Structure for Nimmo's Bridge, Structural works at Drunghill Tunnel West, Drung Hill Tunnel Middle, Drung Hill Tunnel East, and proposed bridge at Kilkeehagh at Ch 25645.</p> <p>2. Caherciveen (Valentia Estuary) Bridge (CH 5180) The Caherciveen (Valentia Estuary) will require remedial and upgrading works to allow safe pedestrian use of the bridge.
